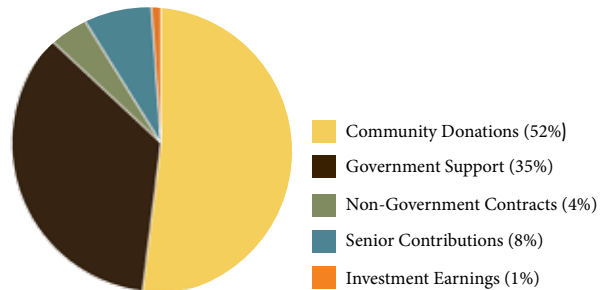

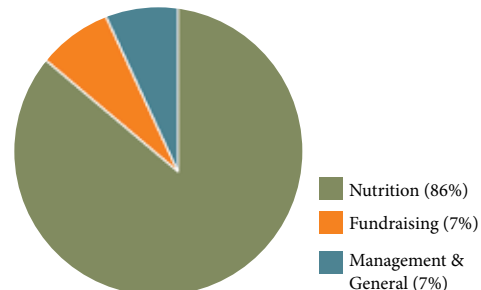

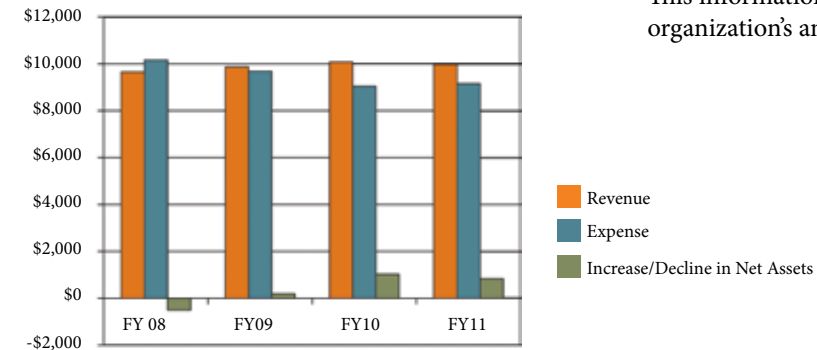
Revenues

Alpenrose and Shari's Café teamed up to help us with two different projects this year. The "Your Small Change Makes a Big Difference" campaign centers around pint-sized Milk Carton Coin Banks. Distributed to individuals, businesses, churches, schools and service clubs, the Coin Banks can be filled and returned to any Loaves & Fishes Center or Shari's Café. Thousands of banks were turned in the first six months, resulting in \$10,134. During May and June, Shari's donated a portion of every milkshake made with Alpenrose ice cream to create awareness for seniors in need in our community. The "Shake Things Up" promotion brought in \$15,000. New Seasons Market raised more than \$30,000 for us last year by donating 50¢ from the sale of every loaf of their organic sourdough bread.
